LEGAL DESCRIPTION
PERMANENT RIGHT-OF-WAY

AIRPORT ROAD IMPROVEMENTS
ROCKWALL, ROCKWALL COUNTY, TEXAS

BEING 0.113 acre of land located in the E.M. ELLIOTT SURVEY, ABSTRACT No. 77, Rockwall, Rockwall County, Texas, and being a portion of the tract of land conveyed to Donna May Puckett and husband, Mike Puckett, by the deed recorded in Volume 5422, Page 89, of the Deed Records of Rockwall County, Texas. Said 0.113 acre of land being more particularly described by metes and bounds as follows:

BEGINNING at a "PK" nail found at the Northeast corner of said Puckett Tract, and lying in the centerline of Airport Road;

THENCE S 00° 30' 07" E 44.09 feet, along the East boundary line of said Puckett Tract, to a ½" iron rod stamped "Brittain & Crawford" set, in the new South right-of-way line of said Airport Road;

THENCE S 89° 26' 31" W 114.28 feet, along the new South right-of-way line of said Airport Road, to a ½" iron rod stamped "Brittain & Crawford" set, in the West boundary line of said Puckett Tract;

THENCE N 00° 31' 33" W 42.09 feet, along the West boundary line of said Puckett Tract, to a "PK" nail found, at the Northwest corner of said Puckett Tract, and lying in the centerline of said Airport Road;

THENCE N 88° 26' 16" E 114.32 feet, along the North boundary line of said Puckett Tract, and the centerline of said Airport Road, to the POINT OF BEGINNING, containing 0.113 acre (4,924 square feet) of land.

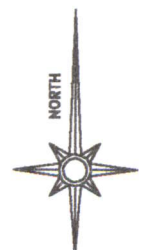
