


GENERAL_NOTES

- 1. MAXIMUM SLOPE ON BARRIER FREE RAMPS SHALL NOT EXCEED 1" PER FOOT AT ANY LOCATION.
- 2. DESIGNS SHOWN ARE FOR 6" CURBS. FOR CURBS GREATER THAN 6" DIMENSIONS SHALL BE INCREASED PROPORTIONATELY.
- 3. STREETS ON STEEP GRADE WILL REQUIRE LONGER CURB TRANSITIONS. IT IS THE DESIGN ENGINEER'S RESPONSIBILITY TO INSURE THAT THIS DETAIL WILL WORK
- 4. LOCATIONS OF BARRIER FREE RAMPS MAY BE SHIFTED TO CLEAR OBSTRUCTIONS, WITH APPROVAL FROM THE CITY.
- 5. CONCRETE TO HAVE A MINIMUM 3000 PSI COMPRESSIVE STRENGTH AT 28 DAYS.
- 6. REINFORCEMENT TO BE #3 BARS AT 24" O.C.E.W.
- 7. GROOVES MUST BE CLEAN AND STRAIGHT FOR CLEAR DETECTION BY TOUCH WITH A CANE AND PARALLEL TO CROSSWALKS.
- 8. FOR PURPOSES OF WARNING, THE FULL WIDTH AND DEPTH OF CURB RAMPS SHALL HAVE A LIGHT REFLECTIVE VALUE AND TEXTURE THAT SIGNIFICANTLY CONTRASTS WITH THAT OF ADJOINING PEDESTRIAN ROUTES. CITY SHALL APPROVE MATERIALS AND COLOR SHALL BE CHROMIX ADMIXTURES QUARRY RED, C-32 (CHROMIX IS MANUFACTURED BY THE L.M. SCOFIELD CO. (800)800-9900) OR APPROVED EQUAL.







DETAIL FOR RAMP SIDEWALK NOT AT BACK OF CURB

GENERAL NOTES

- 1. CONCRETE TO HAVE A MINIMUM 3000 PSI COMPRESSIVE STRENGTH AT 28 DAYS.
- 2. REINFORCEMENT TO BE #3 BARS AT 24" O.C.E.W.
- 3. GROVES WILL BE INSTALLED ON ALL SIDEWALK/ALLEY INTERSECTIONS. THE GROVES WILL BE THE WIDTH OF THE SIDEWALK. THE GROOVES SHALL BE INSTALLED SO THAT WATER DOES NOT ACCUMULATE.
- 4. IF THE SLOPE OF THE SIDEWALK TO THE ALLEY EXCEEDS 1: 20 (5%) IT WILL BE CONSIDERD A CURB RAMP AND THE FOLLOWING NOTES SHALL APPLY:
- A. MAXIMUM SLOPE ON BARRIER FREE RAMPS SHALL NOT EXCEED 1" PER FOOT AT ANY LOCATION.
- B. LOCATIONS OF BARRIER FREE RAMPS MAY BE SHIFTED TO CLEAR OBSTRUCTIONS, WITH APPROVAL FROM THE CITY.
- C.THE SIDEWALK SHALL BE COLORED CONCRETE AND GROVES THE FULL WIDTH OF THE SIDEWALK FOR A LENGTH THAT IS NEEDED TO ACHIEVE THE PROPER SLOPE ON THE RAMP. (SEE DETAIL)
- D. GROOVES MUST BE CLEAN AND STRAIGHT FOR CLEAR DETECTION BY TOUCH WITH A CANE AND PARALLEL TO CROSSWALKS. GROVES MUST BE DONE SO THAT WATER IS NOT ALLOWED TO ACCUMULATE.
- E. FOR PURPOSES OF WARNING, THE FULL WIDTH AND DEPTH OF CURB RAMPS SHALL HAVE A LIGHT REFLECTIVE VALUE AND TEXTURE THAT SIGNIFICANTLY CONTRASTS WITH THAT OF ADJOINING PEDESTRIAN ROUTES. CITY SHALL APPROVE MATERIALS AND COLOR SHALL BE CHROMIX ADMIXTURES QUARRY RED, C-32 (CHROMIX IS MANUFACTURED BY THE L.M. SCOFIELD CO. (800)800-9900) OR APPROVED EQUAL.
