This letter is to document the completion of the work described in our letter dated May 30, 2003. The PVC water line that was inadvertently left in place at the subject property was filled with polyurethane on June 4, 2003. After excavations in the front and back yards exposed the pipe, the pipe was cut to provide access to the interior of the pipe. A plug of polyurethane was first placed at both ends of the pipe. A small hole was drilled through each plug to allow an injection rod to be inserted into the pipe. Then, the pipe was filled from both ends with polyurethane. Finally, a "collar" of polyurethane was placed around both ends of the pipe as described in our letter. David P. Lutz. P.E. of Fugro South, observed the placement of the polyurethane.
