

WHEREAS Royal Park Place Company is the owner of a tract of land in the County of Rockwall, State of Texas, said tract being described as follows:

BEING a tract or parcel of land out of the A. Amick Survey, Abstract No. 242 and the B. F. Baydun Survey, Abstract No. 14, Rockwall County, Texas; also being a part of a certain tract of land conveyed to G. C. Rockwell, Jr. from J. S. Bourn and wife by deed recorded in Volume 41, Page 319, Deed Records, Rockwall County, and a 4.38 acre tract conveyed by Mae Gardanhire by deed recorded in Volume 34, Page 573, Deed Records, Rockwall County, and being more particularly described as follows:

BEGINNING on the City of Dallas Take Line for Lake Ray Hubbard at a concrete monument stamped AA36-1, AA33-1, said monument being at the Southwest corner of Stone Bridge Meadows, as recorded in Volume 2, Page 14, Plat Records, Rockwall County;

THENCE: South 89° 54' 56" East with the South line of Stone Bridge Meadows a distance of 1015.17 feet to the Southeast corner of Stone Bridge Meadows and an iron pipe on the West line of High Ridge Estates as recorded in Volume 3, Page 11, Plat Records, Rockwall County, for a corner;

THENCE: South 9° 31' 07" East with the West line of High Ridge Estates a distance of 298.03 feet to an iron rod for a corner;

THENCE: South 89° 11' 22" East with the South line of said subdivision a distance of 132.66 feet to the Northwest corner of Lake Meadows Estates, as recorded in Volume 1, Page 77, Plat Records, Rockwall County, and an iron pipe for a corner;

THENCE: South 44° 21' 43" West with the Northwest line of Lake Meadows Estates a distance of 348.99 feet to an iron rod for a corner;

THENCE: South 46° 09' 49" West with the Northwest line of Ridge Road Village No. 2, as recorded in Volume 2, Page 21, Plat Records, Rockwall County, a distance of 510.50 feet to an iron pipe on the City of Dallas Take Line for a corner;

THENCE: South 67° 56' 01" West with said Take Line a distance of 213.77 feet to an iron rod for a corner;

THENCE: North 21° 31' 21" West continuing along said Take Line a distance of 1054.18 feet to the Point of Beginning and Containing 16.023 Acres of Land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS:

That Royal Park Place Company being owner does hereby adopt this plat designating the hereinabove described property as Royal Park Place, Rockwall County, Texas, and does hereby dedicate to the public use forever the streets and alleys shown thereon, and does hereby reserve the easement strips shown on this plat for the purposes stated and for the mutual use and accommodation of all utilities desiring to use or using same. Any public utility shall have the right to remove and keep removed all or part of any building, fence, trees, shrubs, or other growths or improvements which in any way endanger or interfere with construction, maintenance or efficiency of their respective system on any of these easement strips; and any public utility shall have the right of ingress or egress to, from and upon the said easement strips for purpose of construction, reconstruction, inspecting, patrolling, maintaining, and either adding to or removing all or part of their respective systems without the necessity of at any time, procuring the permission of anyone. The City of Rockwall will not be responsible for any claims of any nature resulting from or occasioned by the establishment of grades of streets in this subdivision.
