#### GENERAL NOTES (APPLICABLE TO ALL SHEETS)

- 1. Excavated material shall be placed as directed by the Owner.
- 2. Construction shall meet the requirements of the latest revision of the Standards of Design and Standard Details for the City of Rockwall & NTCOG Standards, 3rd Edition.
- 3. All fill areas to be density controlled and compacted to 95% density at optimum moisture content. Compacted with sheep foot roller.
- 5. All subgrade of proposed parking shall be compacted to 95% standard proctor density. All general fill material to be compacted with a sheepsfoot roller.
- 6. It shall be the responsibility of the Contractor to locate and verify all existing utilities prior to the beginning of construction to insure no conflicts between all utility lines.
- 7. All handicap ramps shall be installed with paving.
- 8. Contractor is responsible for acquiring NTCOG 3rd Edition and Rockwall Standards and Details.
- 9. Existing 4" Sanitary Sewer and 3/4" Water will continue to be used for the service of this structure. No irrigation system is planned to be installed at this time.




