

VICINITY MAP





GENERAL NOTES

- 2. CONTRACTOR TO FIELD VERIFY THE FLOW LINE ELEVATION WHEN TYING TO EXISTING SYSTEM.
- 3. ALL SANITARY SEWER CONNECTIONS SHALL HAVE
- DOUBLE CLEANOUTS AND LOCATED FOR ACCESS PER CITY OF ROCKWALL SPECIFICATIONS.
- 4. GREEN EMS DISKS TO BE INSTALLED AT EVERY MANHOLE AND SERVICE.
- 5. ALL BACK FLOW PREVENTORS ARE INSIDE THE

BUILDING.

6. A MINIMUM OF 5' CLEARANCE BE MAINTAINED AROUND ALL FIRE HYDRANTS.
