LEGAL DESCRIPTION
PERMANENT RIGHT-OF-WAY
PARCEL 18
AIRPORT ROAD IMPROVEMENTS
ROCKWALL, ROCKWALL COUNTY, TEXAS

BEING 0.393 acre of land located in the D. HARR SURVEY, Abstract No. 102, Rockwall, Rockwall County, Texas, and being a portion of the tract of land designated as Tract B1 in the deed to Bobby Frank Athey, recorded in Volume 4875, Page 117, of the Deed Records of Rockwall County, Texas. Said 0.393 acre of land being more particularly described by metes and bounds as follows:

BEGINNING at a "PK" nail found at the Northwest corner of said Tract B1, and lying within the existing right-of-way area of Airport Road;

THENCE N 89° 50' 45" E 365.99 feet, along the North boundary line of said Tract B1, and along said Airport Road, to a "PK" nail found at the Northeast corner of said Tract B1;

THENCE S 00° 50' 30" E 42.87 feet, along the East boundary line of said Tract B1, to a ½" iron rod stamped "Brittain & Crawford" set, in the new South right-of-way line of said Airport Road;

THENCE along the new South right-of-way line of said Airport Road as follows;

1. S 88° 25' 34" W 247.92 feet, to a ½" iron rod stamped "Brittain & Crawford" set, at the beginning of a curve to the Right;
2. SOUTHWESTERLY 30.56 feet, along said curve to the Right, having a radius of 732.50 feet, a central angle of 02° 23' 24", and a chord bearing S 89° 37' 16" W 30.55 feet, to a ½" iron rod stamped "Brittain & Crawford" set, at the end of said curve;
3. N 89° 11' 02" W 87.55 feet, to a ½" iron rod stamped "Brittain & Crawford" set, in the West boundary line of said Tract B1;

THENCE N 00° 50' 29" W 47.65 feet, along the West boundary line of said Tract B1, to the POINT OF BEGINNING, containing 0.393 acre (17,126 square feet) of land.

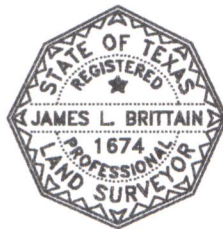

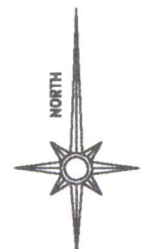
