SUB LEASE DESCRIPTION PROJECT NO. TL2004-068

STATE OF TEXAS COUNTY OF ROCKWALL

BEING a tract of land situated in the City of Dallas Takeline Area and being a portion of a tract of land leased to the City of Rockwall and being more particularly described as follows:

BEGINNING at a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." at the most southwesterly corner of LOT 4, BLOCK A of GRADY RASH SUBDIVISION, an addition to the City of Rockwall as recorded in Cabinet B, Page 142 of the Plat Records of Rockwall County, Texas (PRRCT);

THENCE along the southerly line of said LOT 4, BLOCK A South 68 deg 37 min 16 sec East a distance of 151.02 feet to a 1/2 inch iron rod set with a red plastic cap stamped "W.A.I." for corner at the most southeasterly corner of said LOT 4, BLOCK A;

THENCE departing the southerly line of said LOT 4, BLOCK A South 22 deg 07 min 31 sec West passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 296.83 feet, continuing in all a distance of 306.83 feet to a point for corner in the 435.5 contour line as defined at the time of the survey;

THENCE along the meanders of said 435.5 contour line in a northwesterly direction a distance of 157.3 feet to a point for corner;

THENCE departing said 435.5 contour line North 22 deg 14 min 08 sec East passing a 3 1/2 inch Aluminum Monument stamped "CITY OF ROCKWALL LAKE RAY HUBBARD SUB LEASE MARKER 2004" at a distance of 10.00 feet, continuing in all a distance of 282.12 feet to the POINT OF BEGINNING;

CONTAINING within these metes and bounds 1.029 acres or 44,836 square feet of land, more or less.
