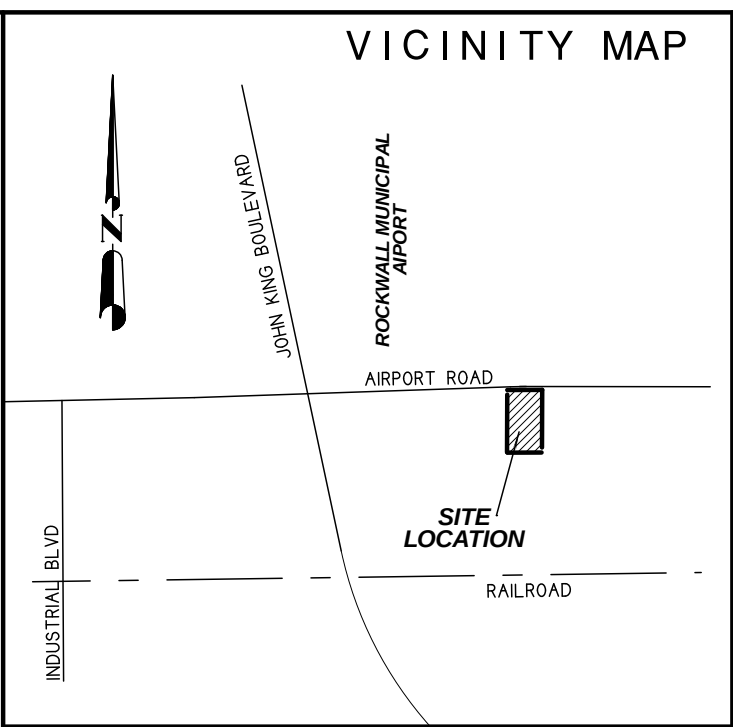
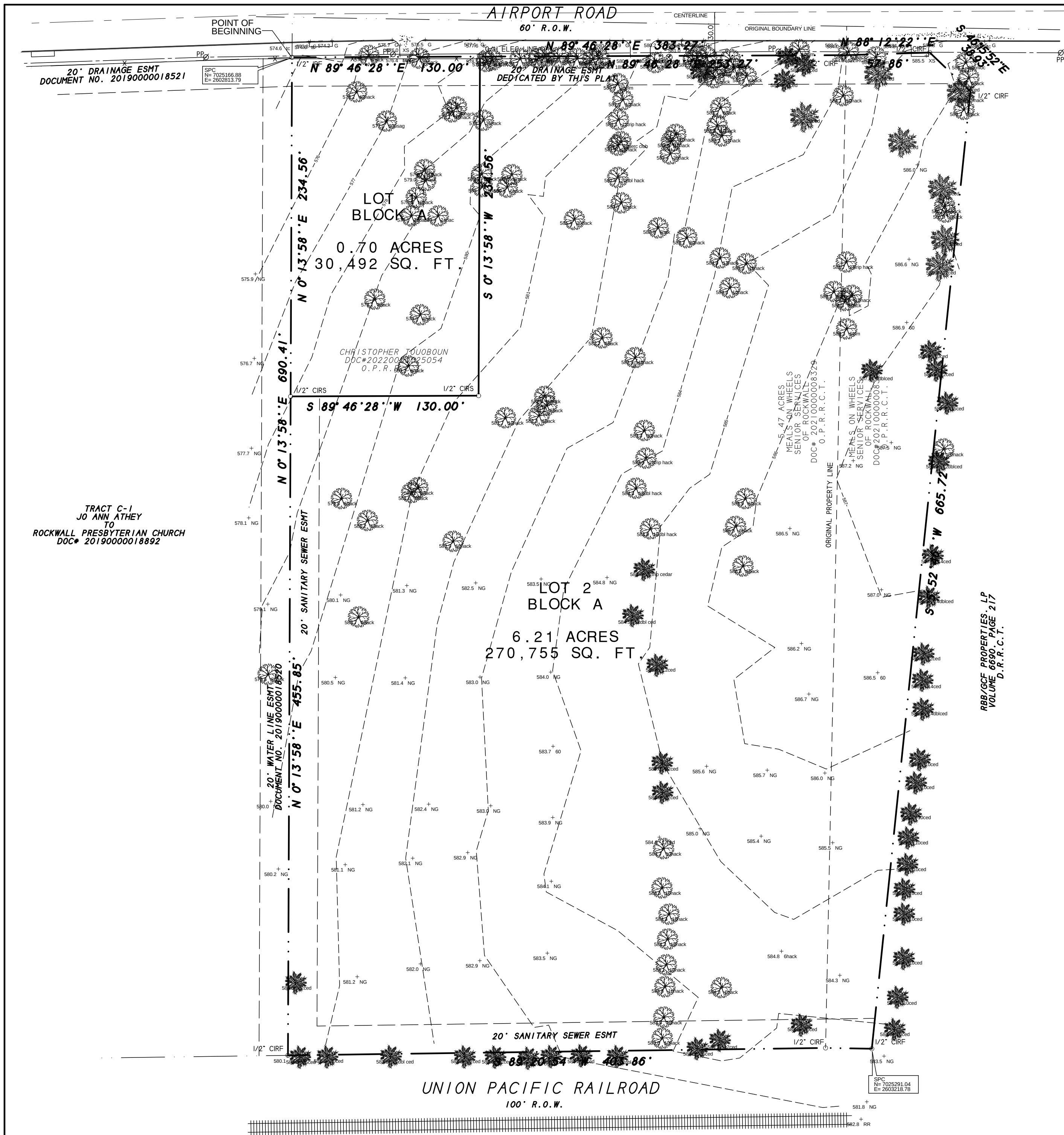
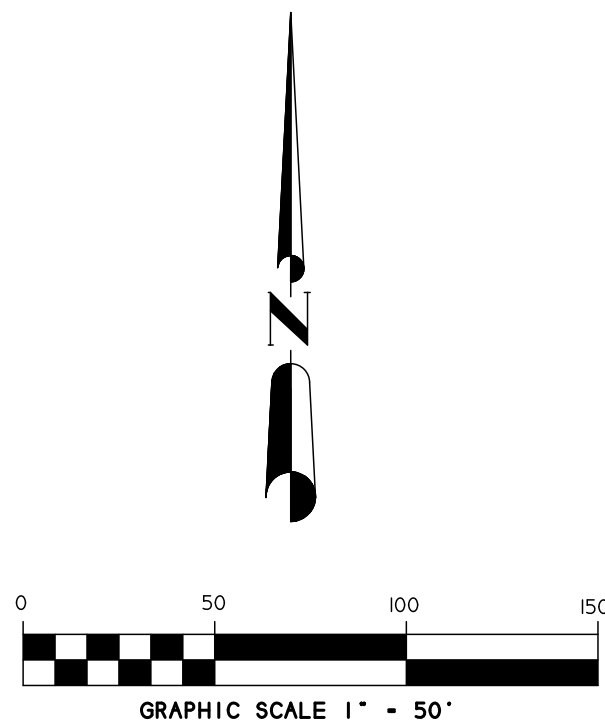




- SURVEYOR'S NOTES
