AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF ROCKWALL, ROCKWALL COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Rockwall, Texas, has been signed by the majority of the inhabitants of such described territory who are qualified to vote for members of the State Legislature; and,

WHEREAS, said land is adjoining the City of Rockwall and said petition was presented to the Mayor and City Council of the City of Rockwall requesting the annexation of said territory to said City; and,

WHEREAS, the members of the City Council of the City of Rockwall have approved the petition requesting the annexation of said territory; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKWALL, TEXAS:

SECTION 1. That the following described property, to-wit:

BEGINNING: At a stake in the East City limits line, said point being on the South right of way line of the M-K-T Railroad, said point being originally the Southeast corner of old City limits:

THENCE: South 0500 ft. distance

THENCE: West 5760 ft. distance to the present North-east corner of said City Limits; (THENCE along the present City limits line to the place of beginning as follows:)

THENCE: South 12 deg. 14' East 1636 ft. distance with present City Limits East line to point of curve in State Highway #205;

THENCE: Along the South right of way line of State Highway #205 Curve to right, South 5 deg. 15' East 800 ft.; south 3 deg. East 204 ft. and South 445 ft. distance to a stake for a corner;

THENCE: East 1280 ft. distance with old City Limits line to a stake in the Wade Addition for a corner;

THENCE: North 870 ft. distance with the Wade Addition West line to a stake for a corner;

THENCE: East 880 ft. distance to a stake for a corner;

THENCE: South 870 ft. distance to a stake for corner;

THENCE: East 660 ft. distance to a stake for a corner;

THENCE: South 5550 ft. distance with old City Limits line to the place of beginning. All lines running parallel to the present City Limits lines and does not exceed 2640 ft.;

be, and the same is hereby annexed to the City of Rockwall, Rockwall County, Texas, and that the boundary limits of the City of Rockwall be and the same are hereby extended to include the above described territory within the city limits of the City of Rockwall, and the same shall hereinafter be included within the territorial limits of said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Rockwall, and they shall be bound by the acts, ordinances, resolutions and regulations of said City.

SECTION 2. That this ordinance shall take effect from and after its passage as the law in such cases provides.

FIELD NOTES, CITY LIMITS, EAST, FOR THE CITY OF ROCKWALL,
ROCKWALL COUNTY, STATE OF TEXAS.

BEGINNING: At a stake in the East City limits line, said point being on the South right of way line of the M-K-T Railroad, said point being originally the Southeast corner of old City Limits;

THENCE: South 3960 ft. distance along new City Limits East line to a stake in the Southeast corner of said City Limits;

THENCE: East 2640 ft. distance, crossing U. S. 67 Highway, old McClendon-Chisholm road to a stake in Frank Rhoades tract of land;

THENCE: North 12595 ft. distance to a stake in the Frank Phelps tract of land for a corner;

THENCE: West 5760 ft. distance to the present Northeast corner of said City Limits; (THENCE along the present City limits line to the place of beginning as follows:)

THENCE: South 12 deg. 14' East 1636 ft. distance with present City Limits East line to point of curve in State Highway #205;

THENCE: Along the South right of way line of State Highway #205 Curve to right, South 5 deg. 15' East 800 ft.; south 3 deg. East 204 ft. and South 445 ft. distance to a stake for a corner;

THENCE: East 1280 ft. distance with old City Limits line to a stake in the Wade Addition for a corner;

THENCE: North 870 ft. distance with the Wade Addition West line to a stake for a corner;

THENCE: East 880 ft. distance to a stake for a corner;

THENCE: South 870 ft. distance to a stake for a corner;

THENCE: East 660 ft. distance to a stake for a corner;

THENCE: South 5550 ft. distance with old City Limits line to the place of beginning. All lines running parallel to the present City Limits lines and does not exceed 2640 ft.
