AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO
THE CITY OF ROCKWALL, ROCKWALL COUNTY, TEXAS, AND EXTENDING THE BOUNDARY
LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY
WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS AND OWNERS
OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS
AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS
AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Rockwall, Texas, has been signed by the majority of the inhabitants of such described territory who are qualified to vote for members of the State Legislature; and,

WHEREAS, said land is adjoining the City of Rockwall and said petition was presented to the Mayor and City Council of the City of Rock-wall requesting the annexation of said territory to said City; and,

WHEREAS, the members of the City Council of the City of Rockwall have approved the petition requesting the annexation of said territory; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKWALL, TEXAS:
SECTION 1.

BEGINNING: At a point in the South line of Tract #2, said point also being the most Southeast corner of present city limits;

THENCE: South a distance of 2,640 feet to a stake for a corner;

THENCE: West a distance of 9,313 feet and parallel to South line of Tract #2 to a stake in the East Fork of the Trinity River for a corner;

THENCE: In a Northeasterly direction with the meandering of said River a distance of 3,111 feet, more or less, to a stake in the Southwest corner of Tract #2;

THENCE: East along the South line of Tract #2 a distance of 8,030 feet to the place of beginning.

Proposed City Limit line running parallel and one-half mile distance

within the city limits of the City of Rockwall, and the same shall hereinafter be included within the territorial limits of said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Rockwall, and they shall be bound by the acts, ordinances, resolutions and regulations of said City.

SECTION 2. That this ordinance shall take effect from and after its passage as the law in such cases provides.
