AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF ROCKWALL, ROCKWALL, COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS AND OWNERS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition requesting that the hereinafter described territory be annexed to the City of Rockwall, Texas, has been signed by the majority of the inhabitants of such described territory who are qualified to vote for members of the State Legislature; and,

WHEREAS, said land is adjoining the City of Rockwall and said petition was presented to the Mayor and City Council of the City of Rockwall requesting the annexation of said territory to said City; and,

WHEREAS, the members of the City Council of the City of Rockwall have approved the petition requesting the annexation of said territory; NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCKWALL, TEXAS:

SECTION 1. That the following described property, to-wit:

BEGINNING: At a point in the South line of Tract #1, a distance of 2640 feet from the Southeast corner of Tract #1, said point also being in South City limit line;

THENCE: South 45° West a distance of 3,734 feet;

THENCE: West a distance of 8,630 feet to a stake in the East Fork of the Trinity River for a corner;

THENCE: North a distance of 5,280 feet to a stake for a corner;

be, and the same is hereby annexed to the City of Rockwall, Rockwall County, Texas, and that the boundary limits of the City of Rockwall be and the same are hereby extended to include the above described territory within the city limits of the City of Rockwall, and the same shall hereinafter be included within the territorial limits of said City and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Rockwall, and they shall be bound by the acts, ordinances, resolutions and regulations of said City.

SECTION 2. That this ordinance shall take effect from and after its passage as the law in such cases provides.

PROPOSED FIELD NOTES FOR THE CITY LIMITS OF THE CITY OF ROCKWALL, TEXAS:

BEGINNING: At a point in the South Line of Tract #1, a distance of 2640 feet from the Southeast corner of Tract #1, said point also being in South City Limit Line.

THENCE: South 45° West a distance of 3734 feet;

THENCE: West a distance of 8030 feet to a stake in the East Fork of Trinity River for a corner;

THENCE: North a distance of 5280 feet to a stake for a corner;

THENCE: East a distance of 2640 to the Northwest corner of Tract #1;

THENCE: South along the West line of Tract #1, a distance of 2640 feet to a point for a corner, said point being the Southwest corner of Tract #1;

THENCE: East a distance of 8030 feet along the south line of Tract #1 to the place of beginning.

Proposed City Limit Line running parallel and one-half mile distance from the present City Limit Line.
