## **Background Information:**

This property was zoned PD for use as a lumberyard/hardware facility. Some time after it was zoned the City acquired it for future use as a water storage yard and a pump station. The only use authorized under the PD is the lumberyard/hardware facility and we need to rezone the property to allow municipal uses. The property was previously zoned Light Industrial and the surrounding zoning is Light Industrial. We would recommend that the zoning be changed back to Light Industrial.

# **Background Information:**
