





Dr. Brooks has made an application to install a new sign at his office on Ridge Road. His lot is strangely shaped as it relates to the FM-740 ROW. His property line is set back further than either of the two parcels beside him. Additionally, there is considerable plnat growth on either side of him that make visibility a problem.
