


EXHIBIT "A"

BEING a 12' Fire Lane easement across a part of Lot 1, Block A, STEELE ADDITION, an Addition to the City of Rockwall, Rockwall County, Texas, according to the Plat thereof recorded in Cabinet G, Slide 121-122 of the Plat Records of Rockwall County, Texas, and being more particularly described as follows:

BEGINNING at a ½" iron rod found for corner in the east right-of-way line of N. Goliad Street SH 205, at the northwest corner of said STEELE ADDITION and at the southwest corner of REPLAT W.D. AUSTIN ADDITION PART OF LOT 2, an Addition to the City of Rockwall, Rockwall County, Texas, according to the Plat thereof recorded in Cabinet F, Slide 211 of the Plat Records of Rockwall County, Texas;

THENCE N. 86 deg. 16 min. 22 sec. E. along the common line between said Additions, a distance of 124.86 feet;

THENCE S. 03 deg. 43 min. 28 sec. E. a distance of 12.00 feet;

THENCE S. 86 deg. 16 min. 22 sec. W. a distance of 125.72 feet to a point in the east right-of-way line of N. Goliad Street SH 205;

THENCE N. 00 deg. 21 min. 57 sec. E. along said right-of-way line, a distance of 12.03 feet to the POINT OF BEGINNING and containing 1503 square feet in said easement.
