PAVING NOTES:

1) APPROACHES TO BE 6" THICK, 3600 psi, 6.5 SACK MIX, REINFORCED WITH #3 BARS @ 18" ON CENTER. (O.C.) 2) ALL NON-FIRELANE PAVING CAN BE 6" THICK, 3000 psi, 6 SACK

MIX, REINFORCED WITH #4 BARS @ 18" O.C. 3) ALL FILL (IF REQUIRED) SHALL BE PLACED ON 8" LIFTS AND COMPACTED TO 95% OF STD. PROCTOR @ MOISTURE RANGE OF

0% TO +6% OF OPTIMUM MOISTURE. (UNLESS OTHERWISE NOTED) USING A SHEEPS-FOOT ROLLER.

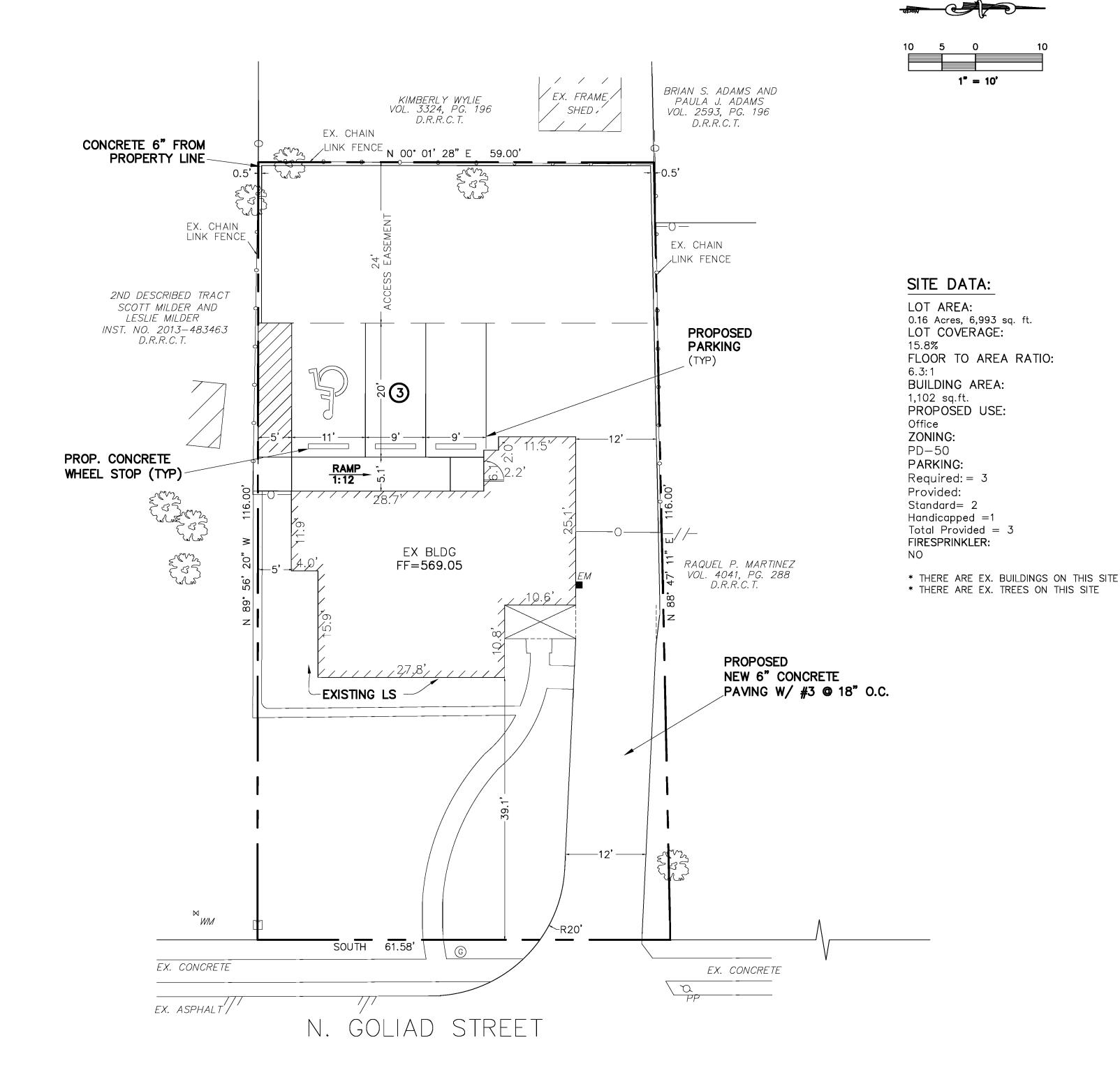

4. Mechanical units, dumpster and trash compactors shall be

screened in accordance with the Zoning Ordinance All signage contingent upon Building Inspection Department.

6. Approval of the site plan is not final until all engineering plans are approved. 7. Open storage, where permitted, shall be screened in accordance

with the Zoning Ordinance 8. Please contact the Building Inspection Department to determine the type of construction and occupancy group.

9. All electrical transmission, distribution and service lines must be underground.
